“RESOLUTION RECOMMENDING THE ISSUANCE OF AWARD IN FAVOR OF YUNG SUNG INDUSTRIAL PHILIPPINES, INC. FOR THE PROCUREMENT OF TOOLINGS FOR 5.56mm PRIMER NEW VERTICAL CUP PUNCHING MACHINE UNDER RFQ # GA BAC-DC-18-07”

WHEREAS, the Procurement of Toolings for 5.56mm Primer New Vertical Cup Punching Machine with an Approved Budget for the Contract (ABC) amounting to PhP7,912,000.00 was programmed in the FY 2018 Annual Procurement Plan under Indirect Production Supplies and Materials - Fabrication Supplies (Page 2 IIA 2);

WHEREAS, procurement of the items was recommended to be undertaken thru Alternative Method-Direct Contracting pursuant to Sec. 50 of the Revised IRR of RA 9184;

WHEREAS, being the exclusive distributor of the item, Request for Quotation (RFQ) was served to Yung Sung Industrial Philippines, Inc. on 17 May 2018;

WHEREAS, during the opening of quotation on 24 May 2018, Yung Sung Industrial Philippines, Inc. has complied with the eligibility requirements including the submission of Exclusive Distributorship, as stated in the RFQ;

WHEREAS, the price proposal in the total amount of PhP7,912,000.00 is within the ABC;

WHEREAS, the offered delivery period of one hundred eighty (180) calendar days from receipt of Purchase Order is acceptable with the end-user;

WHEREAS, the GA TWG recommended to the GA BAC the declaration of Yung Sung Industrial Philippines, Inc.'s financial proposal in the amount of PhP7,912,000.00 as responsive; and the issuance of corresponding award in favor of Yung Sung Industrial Philippines, Inc.;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that WE, the members of the GA BAC approve and adopt the GA TWG's recommendation to award the supply and delivery of Toolings for 5.56mm Primer New Vertical Cup Punching Machine in the amount of

PhP7,912,000.00 in favor of Yung Sung Industrial Philippines, Inc. and recommends to the Director, GA, the issuance of Notice of Award.
