"A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 5.56MM M855 / SS109 BULLET UNDER IB# GA-BAC-2019DP-01"

WHEREAS, the Invitation to Bid (IB) for the Procurement of 11,000,000pcs 5.56mm M855 / SS109 Bullet for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP49,200,000.00 was published in the Manila Times on 04 October 2018 and posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 04 to 11 October 2018;

WHEREAS, prior to the bid opening, only Poongsan Corporation of South Korea secured bidding documents;

WHEREAS, during the submission and opening of bids on 26 October 2018, said bidder submitted its eligibility & technical and financial proposals which were all rated "passed";

WHEREAS, tabulated below is the result of the opening of the financial proposal:

WHEREAS, from the above result the GA BAC TWG I recommended to the GA BAC the declaration of Poongsan Corporation as the Single Calculated Bidder (SCB) and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-088 dated 07 November 2018;

WHEREAS, the result of the post-qualification to Poongsan Corporation conducted on September 2018 by the DND-BAC PQ Team headed by Dir Dinna Anna Lee L. Cartujano, was adopted on this procurement project;


WHEREAS, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended Poongsan Corporation as qualified to undertake the supply and delivery of 11,000,000pcs 5.56mm M855 / SS109 Bullet;




