

## Contract Agreement

THIS AGREEMENT made this 06 day of FEB 06 2019 between **GOVERNMENT ARSENAL**, Camp General Antonio Luna, Limay, Bataan of the Philippines (hereinafter called "the Entity") of the one part and **AVESCO MARKETING CORPORATION** of 810 Aurora Boulevard corner Yale Street, Cubao, Quezon City (hereinafter called "the Supplier") of the other part:


WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Lot II – 30,000 kgs 7.62mm Carbon Steel Strip, IB Nr. 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.






