“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF MATERIALS FOR WIRE-BOUND CRATE UNDER IB# GA-BAC-2019DF-09”

WHEREAS, the Invitation to Bid (IB) for the Procurement of Materials for Wire-Bound Crate for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP3,169,445.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 15 to 22 November 2018;

WHEREAS, prior to the bid opening, only Up-Town Industrials Sales, Inc. secured bidding documents;

WHEREAS, during the submission and opening of bids on 07 December 2018, said bidder submitted its eligibility & technical and financial proposals which were all rated “passed”;

WHEREAS, tabulated below is the result of the opening of the financial proposal:

WHEREAS, as a result the GA BAC TWG I recommended to the GA BAC the declaration of Up-Town Industrial Sales, Inc. as the Single Calculated Bidder (SCB) and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-118 dated 10 December 2018;


WHEREAS, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended the declaration of Up-Town Industrial Sales, Inc. as post-qualified and as the Single Calculated Responsive Bidder (SCRB), hence, qualified to undertake the supply and delivery of Materials for Wire-Bound Crate;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Up-Town Industrial Sales, Inc. as post-qualified and as SINGLE CALCULATED AND RESPONSIVE

BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of Materials for Wire-Bound Crate in the amount of PhP3,159,175.00 under IB Nr. GA-BAC-2019DP-09.



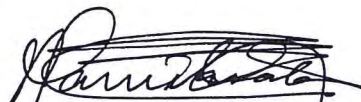
