

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of 2,400,000pcs each 5.56mm and 7.62mm Case for Blank Ammunition for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to PhP49,320,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 11 to 18 January 2019;



**WHEREAS**, the result of the post-qualification to Poongsan Corporation conducted on September 2018 by the DND-BAC PQ Team headed by Dir Dinna Anna Lee L. Cartujano, was adopted on this procurement project;




