

“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 5.56MM M855 / SS109 BULLET (LOT I) UNDER IB# GA-BAC-2019DP-14”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 7,000,000pcs 5.56mm M855 / SS109 Bullet and 3,000,000pcs 7.62mm M13 Links consisting of two (2) lots (Lot I – 5.56mm M855 / SS109 Bullet and Lot II – 7.62mm M13 Links) for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to a total of PhP45,200,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 01 to 08 April 2019;

WHEREAS, Poongsan Corporation's proposal was declared as the Single Calculated Bid (SCB) for Lot I – 5.56mm M855 / SS109 Bullet in the total amount of PhP34,930,000.00, and the conduct of post-qualification pursuant to approved Resolution No. GA-BAC-PB-2019-058 dated 30 April 2019;

WHEREAS, the result of the post-qualification to Poongsan Corporation conducted on November 2018 by the DND-BAC PQ Team headed by Col Carlo Bueno N Buena PAF (MNSA), was adopted on this procurement project;

WHEREAS, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended the declaration of Poongsan Corporation as the SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB), hence, the supplier is qualified to undertake the supply and delivery of 5.56mm M855 / SS109 Bullet;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Poongsan Corporation as the SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of 7,000,000pcs 5.56mm M855 / SS109 Bullet in the total amount of PhP34,930,000.00 under IB Nr. GA-BAC-2019DP-14.
