"A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF CARTON BOXES UNDER IB# GA-BAC-2019DP-15"

WHEREAS, the Invitation to Bid (IB) for the Procurement of Carton Boxes for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to a total of PhP2,140,681.70 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 01 – 08 April 2019;

WHEREAS, Advancekonek Corp's was declared as the Single Calculated Bid (SCB) in the total amount of PhP2,138,137.00, and the conduct of post-qualification pursuant to approved Resolution No. GA-BAC-PB-2019-059 dated 30 April 2019;

WHEREAS, after further verification of the documents submitted, and having complied with the eligibility, technical and financial capability requirements in the bidding documents, the GA BAC TWG I recommended the declaration of Advancekonek Corp.'s bid as Single Calculated and Responsive Bid (SCRB), hence, the supplier is qualified to undertake the supply and delivery of Carton Boxes;
