“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF PLASTIC CRATE (LOT I) AND PLASTIC BAG (LOT II) UNDER IB# GA-BAC-2019DP-16”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 6,900pcs Plastic Crate and 129,500pcs Plastic Bag consisting of two (2) lots (Lot I – Plastic Crate and Lot II – Plastic Bag) for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to a total of PhP3,364,500.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 16 to 23 April 2019;

WHEREAS, Plastimer Industrial Corporation was declared as the Single Calculated Bidder (SCB) for Lot I – Plastic Crate and Lot II – Plastic Bag in the amounts of PhP2,518,500.00 and PhP621,600.00, respectively, and the conduct of post-qualification to the said bidder pursuant to approved Resolution No. GA-BAC-PB-2019-062 dated 14 May 2019;

WHEREAS, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended the declaration of Plastimer Industrial Corporation as post-qualified and as the Single Calculated and Responsive Bidder (SCRB), hence, qualified to undertake the supply and delivery of Plastic Crate and Plastic Bag;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Plastimer Industrial Corporation as post-qualified and as SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award for the procurement of Lot I – Plastic Crate and Lot II – Plastic Bag in the total amount of PhP3,140,100.00 under IB Nr. GA-BAC-2019DP-16.


