“A RESOLUTION APPROVING A 12-DAYS EXTENSION OF POST-QUALIFICATION PERIOD, DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 7.62MM CASE UNDER IB # GA-BAC-2019DP-17”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 2M pcs 7.62mm Case for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to Php32,400,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 05 – 12 July 2019;

WHEREAS, Poongsan Corporation's financial proposal was declared as the Single Calculated Bid (SCB) in the total amount of Php29,160,000.00 pursuant to Resolution No. GA-BAC-PB-2019-085 dated 30 July 2019;

WHEREAS, upon coordination of Poongsan Corporation to GA Post-Qual Team to conduct post-qualification on 23 – 27 September 2019, the GA Post-Qual Team departed on aforesaid date;

WHEREAS, the PQ Team recommends to the GA BAC a 12-day extension of the Post-Qualification;

WHEREAS, upon validation and verification of the eligibility requirements, technical capability and financial proposal, the PQ Team recommended the declaration of Poongsan Corporation's bid as Single Calculated and Responsive Bid (SCRB), hence, the supplier is qualified to undertake the supply and delivery of 7.62mm Case;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC adopts and approves the recommendation of the GA BAC TWG I to:

1. Extend the Post-Qualification for 12 days or until October 1, 2019;
2. Declare Poongsan Corporation as post-qualified;
3. Declare Poongsan Corporation's bid as the Single Calculated and Responsive Bid (SCRB); and
4. Recommend to the Director, GA the issuance of Notice of Award in favor of Poongsan Corporation for the procurement of 2M pcs 7.62mm Case in the total amount of Php29,160,000.00 under IB No. GA-BAC-2019DP-17.
