

“RESOLUTION DECLARING POONGSAN CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 5.56MM CASE FOR BLANK AMMUNITION AND 5.56MM M193 BULLET UNDER IB NR. GA-BAC-2019DP-20”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 5.56mm³ Case for Blank Ammunition and 5.56mm M193 Bullet consisting of two (2) lots (Lot I – 5.56mm Case for Blank Ammunition; Lot II – 5.56mm M193 Bullet) for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to PhP31,680,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 07 to 14 September 2019;

WHEREAS, prior to the bid opening, only Poongsan Corporation secured bidding documents;

WHEREAS, during the submission and opening of bids on 30 September 2019, Poongsan Corporation submitted its eligibility and technical components, which were all rated “passed”;

WHEREAS, the bids of Poongsan Corporation for Lot I (5.56mm Case for Blank Ammunition) in the amount of PhP19,680,000.00 and Lot II (5.56mm M193 Bullet) in the amount of PhP12,000,000.00 were declared as the Single Calculated Bid/s, as per approved Resolution No. GA-BAC-PB-2019-100 dated 01 October 2019;

WHEREAS, after verification of the documents and evaluation on the technical capabilities, the GA TWG I recommended Poongsan Corporation as qualified to undertake the supply and delivery of 2,400,000 pcs 5.56mm Case for Blank Ammunition and 3,000,000 pcs 5.56mm M193 Bullet;

WHEREAS, the Committee acting on the recommendation of the GA TWG I, resolved to affirm and declare Poongsan Corporation as post-qualified and as the Single Calculated and Responsive Bidder (SCRB) for the project and to recommend to the Director, GA, the issuance of Notice of Award in its favor;

NOW THEREFORE, We, the members of the GA BAC, resolve as it is hereby **RESOLVED**, to recommend to the Director, GA, the approval and issuance of Notice of Award in favor of Poongsan Corporation for the Procurement of 5.56mm Case for Blank Ammunition and 5.56mm M193 Bullet in the total amount of PHP31,680,000.00;
