**“RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF UNINTERRUPTIBLE POWER SUPPLY UNDER IB# GA-BAC-2018-IA-20”**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of three (3) units Uninterruptible Power Supply (UPS) for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to PhP1,240,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 15 to 22 October 2018;

**WHEREAS**, prior to the bid opening, LSI Leading Technologies Inc., GDA Power Resources Inc. and Automation Specialists and Power Exponents, Inc. (ASPEX) secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 6 November 2018, only LSI Leading Technologies Inc. and GDA Power Resources Inc. submitted their bids. Automation Specialists and Power Exponents, Inc. (ASPEX) sent a letter to the committee that they could not join the bidding since they could not meet the approved budget for the project;

**WHEREAS**, the eligibility and technical components of LSI Leading Technologies Inc. and GDA Power Resources Inc. were rated “passed” and both were declared eligible to bid;

**WHEREAS**, the bid of LSI Leading Technologies Inc. in the amount of PhP1,141,563.99 was declared as the Lowest Calculated Bid, as per Resolution No. GA-BAC-PB-2018-101 dated 16 November 2018;

**WHEREAS**, after verification of the documents and evaluation on the technical capabilities, the GA-TWG III recommended LSI Leading Technologies Inc. as qualified to undertake the supply and delivery of three (3) units Uninterruptible Power Supply (UPS);


**WHEREAS**, We, the members of GA Bids and Awards Committee, resolve as it is hereby **RESOLVED**, to adopt the recommendation of the GA TWG III to declare LSI Leading Technologies Inc. as the Lowest Calculated and Responsive Bidder in the amount of PhP1,141,563.99 under IB# GA-BAC-2018-IA-20;

**NOW THEREFORE**, the GA BAC recommends to the Director, GA, the approval and issuance of Notice of Award in favor of LSI Leading Technologies Inc. for the Procurement of Uninterruptible Power Supply (UPS) in the amount of PhP1,141,563.99;


