**"A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 9MM CASE AND BULLET UNDER IB# GA-BAC-2018DP-16"**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of 4,320,000pcs each 9mm Case and Bullet for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP50,000,000.00 was published in the Manila Times on 20 July 2018 and posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 20 to 27 July 2018;

**WHEREAS**, prior to the bid opening, Companhia Brasileira de Cartuchos (CBC) of Brazil and Poongsan Corporation of South Korea secured bidding documents and joined the bidding;

**WHEREAS**, during the submission and opening of bids on 13 August 2018, CBC and Poongsan Corporation submitted their eligibility & technical and financial proposals which were all rated "passed";

**WHEREAS**, shown below is the result of the opening of the financial proposal of the aforesaid bidders;

**WHEREAS**, from the above result the GA BAC TWG I recommended to the GA BAC the declaration of Companhia Brasileira de Cartuchos as the Lowest Calculated Bidder (LCB) and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-061 dated 15 August 2018;

**WHEREAS**, the result of the post-qualification to CBC of Brazil conducted on June 2018 by the PQ Team headed by Engr. Jose C. Bobadilla, Provisional Member of DND-BAC, was adopted on this procurement project;


**WHEREAS**, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended CBC of Brazil as qualified to undertake the supply and delivery of 9mm Case and Bullet;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Companhia Brasileira de Cartuchos (CBC) of Brazil as the LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of 4,320,000pcs each 9mm Case and Bullet in the amount of PhP42,292,800.00 under IB Nr. GA-BAC-2018DP-16;
