<p>BDS CI. 12.1(b)(ii)</p> <p>Conformity with technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents together with Manufacturer's Certificate authorizing them to sell and / or supply the Lead Wire for Cal .45; if applicable and Manufacturer's Test and Acceptance Procedure (MTAP) for new bidders; and</p>	<p>BDS CI. 12.1(b)(ii)</p> <p>Conformity with technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents together with Manufacturer's Certificate authorizing them to sell and / or supply the Lead Wire for Cal .45; if applicable and Manufacturer's Test and Acceptance Procedure (MTAP) for new bidders;</p> <p>NOTE: For bidders participating as suppliers, the MTAP must be issued by the actual or principal manufacturer of the lead wire.</p>
